- [N] (6) This Committed Rate shall be the Throughput Fee used in calculating a Volume Incentive Shipper's Deficiency Payment, as applicable.
- [N] (7) An incremental pump-over fee of \$0.10 cents per Barrel will be assessed, in addition to the applicable Uncommitted or Committed Rates set forth herein, for any Barrels that are delivered to these Delivery Points. This fee is subject to adjustment annually as of each July 1 in accordance with the mechanism set forth in FERC regulation 18 C.F.R. § 342.3, or any successor thereto.
- [N] (8) An incremental injection fee of \$0.05 cents per Barrel will be assessed, in addition to the applicable Uncommitted or Committed Rates set forth herein, for any Barrels that are accepted for transportation at these Receipt Points. This fee is subject to adjustment annually as of each July 1 in accordance with the mechanism set forth in FERC regulation 18 C.F.R. § 342.3, or any successor thereto.
- [N] (9) <u>Transportation service provided by Carrier under these Tariffs does not include terminalling service past the inlet flange of the terminal facilities at the Delivery Point. Such terminalling service (including, but not limited to storage, marine loading, etc.) may be available for an additional fee from other Persons besides Carrier.</u>
